

CPS ADVISORY COUNCIL MEETING MINUTES 7/2025

Meeting date: October 6, 2025 11:30 a.m., room no. 136/U17

Individuals present: 42

1) New internal standards issued

- Director's Directive UNI SŘ/02/2025 Rules for determining personal evaluations and rewards of academic and scientific staff
- Director's Instruction UNI $P\dot{R}/02/2025$ Evaluation and management of the development of pedagogical, creative, managerial and other activities of academic and scientific staff of the UNI

The main changes associated with the issuance of the above-mentioned internal UNI standards are as follows:

1. Work points (PB)

Beyond the framework of SR/10/2025 (newly valid from 01. 09. 2025), there have been changes in the valuation of work activities important for the further development of UNI, with the largest increase in PB recorded by contractual research, which is now significantly more valued (from 40 PB for contracts up to 50 thousand CZK to 1000 PB for contracts over CZK 1 million). The aim is to support cooperation with the application sphere and increase motivation to engage in contractual research. Detailed evaluation of other activities with work points can be found in PŘ/02/2025.

2. Transparent categorization of employees

The key point of SŘ/02/2025 is the definition for classifying employees into performance categories 1–5, which subsequently determine the determination of personal evaluation from internal budget funds. In accordance with this directive, new personal evaluations will be awarded for the first time from 1 November 2025.

3) HR Award ((Development of Research and Development Capacities at TBU in Zlín)

On September 22, 2025, a site visit by evaluators from the European Commission took place. UNI/CPS successfully defended the HR Excellence in Research Award. We would like to thank everyone who participated in the RoKaVaV project and the implementation of the site visit.

- Amendment of the Action Plan for the next period
